

VACCINATION CERTIFICATES and FACE COVERINGS

RULES FOR CURRENT PARENTS

- Face coverings are required **at all times** while on site.
- This may be removed if you show us a Vaccine Passport.
- Parents are required to demonstrate they are fully vaccinated if they fall into any of the following categories:
 - Parent helper in class / out of class trip
 - Sports Coach
 - Volunteering time working alongside students.
 - On site in the capacity other than a parent (ie. contractor)

RULES FOR ALL OTHER ADULTS ON SITE

- You need to be able to prove that you are fully vaccinated.

NOTE: Between 15 November 2021 and 1 January 2022 evidence of the first Covid Jab is sufficient.
